3. Bids under the "single stage two envelopes (Technical & Financial) procedure" along with earnest money equivalent to 2% will be received up to 14th March 2023 by 11:30 am.
4. Bids will be opened through the university purchase committee in the presence of bid participants who are willing to be present at 12:00 PM on 14th March 2023.
5. Conditional, incomplete, opened, Emailed and faxed tenders will not be accepted.
6. No supporting document will be accepted at all after the date and time of submission of bids.
7. Prices must be quoted in the space provided in the tender document and not on letter head.
8. After final award, successful bidder(s) will be liable to complete the supply within the stipulated period as per specification given in tender documents. In case of cancelation of supply order due to default of the firm, the earnest money shall be forfeited in favor of LUAWMS, Uthal.
