- 3. The tender document are to be submitted by September 08, 2023 at the office of undersigned up to 11:00 Am where technical proposals will be opened on same date at 11:30 Am in front of bidders who wish to be present or their representative.
- 4. Financial proposals of the technically accepted bids shall be publically opened for which date, time and venue shall be communicated to be bidders in advance.
- 5. The tenders must be accompanied with an earnest money in the prescribed format through deposit of call from schedule bank 3% of the estimated cost. Incomplete tenders and tenders without bid security / earnest money will not be entertained or considered under any circumstance.
